Q: What exactly is the CPA?

A: The Community Preservation Act (CPA) enables cities and towns in Massachusetts to create a dedicated fund for open space, outdoor recreation, historic preservation, and housing for local families – and receive matching state funds for these purposes. The program has been so successful that no community has ever exercised the option to repeal the CPA.

Q: What's this about housing?

A: Under the CPA law, just 10% of the funds must be spent on community housing. Fall River will likely use this small amount to revitalize neighborhoods by converting abandoned buildings or historic properties into housing that is affordable for local families. Most people have said the top priorities for CPA are improving our parks and preserving historic assets.

Q: What are the numbers on the CPA?

A: CPA would be a 1.5% surcharge on the property tax. The average Fall River homeowner would pay only \$19 a year, or \$4.75 per quarterly tax bill. Low income households and low-to-moderate income seniors will be exempt from the CPA surcharge. CPA would raise over one million dollars a year for use in Fall River. Significantly, however, this one million dollars could leverage an additional \$1 million to \$10 million dollars annually in state and federal funds.

Q: Who decides how CPA funds will be used?

A: CPA funds are under local control. Fall River residents on a local CPA Committee will review proposals for local projects and make recommendations to the City Council. All CPA projects must be approved by the City Council to receive CPA funds.
