

The Community Preservation Projects Report (CP-3)

Instruction Manual – Version 1.2, January 2023

WHAT IS THE CP-3?

Each year, all CPA communities are required by the state's Department of Revenue (DOR) to complete the Community Preservation Projects Report (CP-3), accessed through an online application at https://maps.massgis.digital.mass.gov/MassGIS_CPC. Completion of the CP-3 is required for communities to receive their annual distribution from the statewide CPA Trust Fund. Since many projects take years to complete, communities should review and update past projects at the same time they use the application to enter new projects.

The CP-3 provides a web-based form to collect information about your CPA projects, including a description, current status, permanent restrictions, funding, timeline, and location information. Data collected from the CP-3 provides important information to help municipal governments, the state legislature, and the general public understand how CPA funds have been invested to achieve the goals of the Community Preservation Act (CPA). The CP-3 also serves as an ongoing record of all CPA funded projects appropriated by your municipality and helps the Commonwealth account for the millions in matching funds distributed annually.

Below is an excerpt from *Section 13* of the Act explaining that it is the Community Preservation Committee (CPC) at the local level that is officially charged with recordkeeping:

The community preservation committee shall keep a full and accurate account of all of its actions, including its recommendations and the action taken on them and records of all appropriations or expenditures made from the Community Preservation Fund. The committee shall also keep records of any real property interests acquired, disposed of or improved by the city or town upon its recommendation, including the names and addresses of the grantors or grantees and the nature of the consideration. The records and accounts shall be public records. .

HOW TO USE THE CP-3?

Tips & Tools for Success

BROWSERS: Before beginning the CP-3, make sure your browser ([Internet Explorer](#), [Mozilla Firefox](#), [Chrome](#) or [Safari](#)) has been updated to the most recent version. If your computer has an older version, you can update it by clicking on the corresponding browser link below and downloading/installing the newest version (note: if you are having trouble accessing the database on one browser, we suggest trying a different one from the list).

LOGGING OUT: Each time you close your browser window or tab, you will be logged out from the application and must enter your community and password again. After you are finished (submitting a new project, updating previously entered projects, or notifying DOR that you have completed the CP-3 for a fiscal year), simply close the browser. There is no specific “log out” button, but you will be automatically logged out after closing the window.

NAVIGATION: To navigate forward or back while using the CP-3, use your browser’s arrow keys (often found on the top left side of your browser’s navigation bar). The Main Menu of options also appears on each page after you submit or update a project. You can also use those links to navigate the application.

SPREADSHEET DOWNLOAD: To view the entire list of CP-3 projects collected via the CP-3 for your community, first log in to the CP-3 and then go to the **Edit or view previously entered projects** page and click “Export” in the top left corner of the page. It will download a spreadsheet with all your project data to date.

General Navigation and Guidance

VERIFY YOUR RESPONSES: As you progress through the CP-3 form, you will have to click **Continue** at several junctures and **Submit** at the end of the form. At each of these junctures, the application will do a “check” to make sure all fields have been satisfactorily completed. If required information is missing or has not been filled in correctly, that field(s) will turn yellow and an error message will appear in red with the name of the problem field(s). You will need to correct those field(s) before continuing. See the specific section-by-section descriptions below to help you problem-solve for specific fields.

HOVER-TEXT HELP WINDOWS: Most fields throughout the CP-3 form contain a “hover” or “mouse over” option. When you place your cursor over the title of the field, text will appear with an explanation on what that field is looking for. When you move your cursor to a different part of the screen, the description will disappear.

OPTIONAL FIELDS: Although most fields require an answer (and you are encouraged to respond to all questions), a few fields are optional. If you do not know the information to fill into those fields, you will be allowed to leave them blank. You can return to the CP-3 at any point to update the missing information on the optional fields.



HOW TO INPUT PROJECTS INTO THE CP-3

Login

To ensure that information is entered into the proper file, the CP-3 form utilizes two-step login process with a username and password system. When you first access the database, a pop-up window will appear asking for your username and password. The username is the name of your town or city (in all lowercase letters), and the password is a unique code assigned to your community by DOR (if you do not have your community's password, you will need to contact DOR directly for assistance at databank@dor.state.ma.us). Important reminder: Both your username and password should be typed out in all lowercase letters to avoid errors.



User Information

The first time a new user accesses the CP-3, the user information will be recorded and saved in a drop down list titled “User name.” On subsequent visits to the website, the user’s unique name will appear in the dropdown list and it will not be necessary to reenter this information (unless updates are needed).

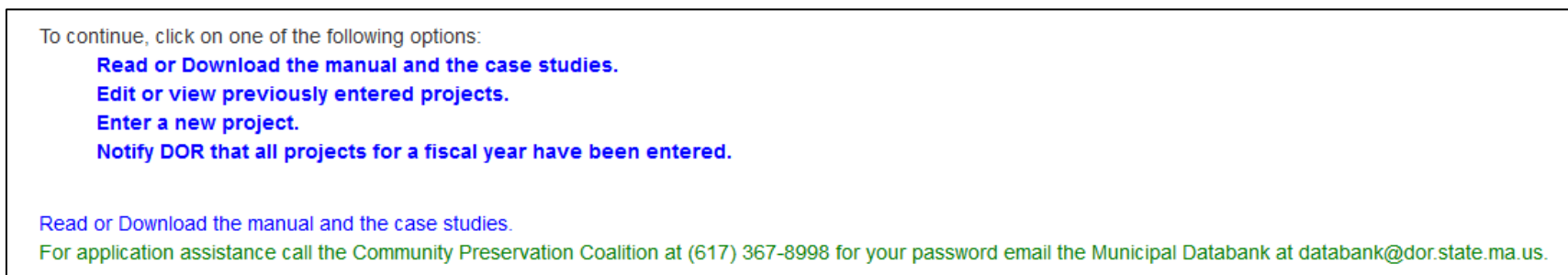

Menu of Options

After logging in and selecting your user name, click **Continue** and scroll down to view a menu of four options.

- 1) **User Manual:** You may download a copy of this manual
- 2) **Edit or view previously entered projects:** You should continuously review previously entered projects to see if they need updating. For example, if the project status has changed or funding amounts have been altered, use the option **Edit or view previously entered projects** to view a list of your community's CPA projects. It is strongly recommended that you first verify and, if necessary, edit the information on each of these projects so that an accurate CPA project history will exist for your community. If your community recently adopted CPA, you may not have any previously entered projects to view or edit. If you click the option labeled Edit or view previously entered projects you will be taken to a blank page. If you do this by accident, simply hit the back arrow to go to the main menu.
- 3) **Enter a new project:** To create a record for a new project, click **Enter a new project**.
- 4) **Notification:** Once you have finished entering all new projects for the past fiscal year, and you have updated all previously entered projects, select **Notify DOR that all projects for a fiscal year have been entered**. This option will allow you to notify DOR that you have complied with the reporting requirement for the previous fiscal year. Communities should also use this option if they did not approve any new CPA projects during the past fiscal year. **WARNING:** the CP-3 notification system does not work consistently across all browsers. If you are having trouble with this step, please contact the Community Preservation Coalition for assistance.




Depending on which option you select from the Main Menu, skip to the corresponding header in subsequent sections of this instruction manual.

Edit or view previously entered projects

You will see a four-column list including all previously entered CPA projects, their description, status, and approval date. You can sort the projects by Project Name, Status or Approval Date by clicking on the underlined header. (Note, this function only sorts alphabetically A to Z or chronologically oldest to newest, and not Z to A or newest to oldest).

* If your community recently adopted CPA, you may not have any projects listed in this section. If you see a blank page, hit the back arrow button and select a different option from the Main Menu.

To view, edit or update a project, click any text on that project's line. A screen with the previously entered project information will populate. You can edit or update any of the information listed on the screen by clicking **Continue** throughout the form and **Submit** at the bottom of the form.

Only hit **Submit** once. It may take up to one minute for the project to submit. Once the project has been successfully submitted, a message in red with a project record ID will appear. You are now free to select a different action from the Main Menu or close the application.

If a project has been canceled, select that option beside the **Project Status** label. Note: project records cannot be deleted. But, by selecting **Project canceled**, you ensure that the information regarding this project will not be included in any CPA fund totals or statistics for your town.

When updating projects entered before August 2014, there may be a few new fields that you will need to fill out. Please update those fields to the best of your ability. To better understand what is required by any field, mouse over the field title and/or see the full descriptions in the next section of the instruction manual entitled **Enter a new project**.

Note: Users do not have permission to change the name of a project once it has been entered into the CP-3 system. If you need amend a project title, please contact the Community Preservation Coalition for assistance.

Enter a new project

This option will take you to a page with a series of sequential questions about your CPA-funded project. As you click through the form by pressing **Continue** at the end of each section, the form will verify that you have filled out all required fields. Please find a description of each field below, listed in the order it appears in the application.

Section: PROJECT INFO

Project Name: If this is a new project, select “Create New Project” and enter a unique, simple, and descriptive title. If this appropriation is another phase of a project that has received funding in the past, please select the original project name from the list, or include a title that indicates which phase of the project it is (PROJECT TITLE Phase 2). This will ensure that each year’s appropriation for a particular project will appear together in alphabetical order on your master list of CPA projects. The following expenditures should not be entered into the CP-3 database: **annual transfers of funding to a reserve account, appropriations from the CPA Administrative Account, or annual payments on bonded projects.**

Approval Date: This is the date that the legislative body (Town Meeting or City Council) voted to appropriate the funding, not the date of the CPC vote to recommend the project, nor the date that the project was actually completed.

Project Status: Indicate the current status of this project. If this project has been canceled, please explain why. Please return to the database and update the status of this project if there is a change in the future.

Description: In a few sentences, please explain the subject, purpose and plan for this project. Please be specific, so that readers who are not familiar with the project will understand the purpose.

Section: PROJECT TYPE

Is this appropriation to a fund/trust?: If this is a transfer of CPA funds to a Housing Trust or a Municipal Conservation Fund, please select “Yes” and then select which fund/trust the money is going to. When the Housing Trust or Conservation Fund spends the money on a project in the future, you will need to return to the database and enter that expenditure as a new project. When entering those projects in the future, be sure to choose “From a Fund/Trust” as the source of funds in the Funding Section of this form. This prevents the money from being counted twice.

Two Important Notes

1. DO NOT ENTER any commas, decimals or money signs in this section. The funding amounts will not be submitted with this formatting. For example, if the project cost \$100,000.00, enter 100000 **not** 100,000 or \$100000.00. If the amount was \$40,555.63, round up and enter 40556.
2. When you arrive at the funding section, there will be a zero (0) in all fields. If a funding source was not used for this project, leave the zero in that field. For some fields an integer is required, so it is advisable to leave the zeroes if you are not replacing them with another amount.

This section includes a series of fields for you to specify this project's funding sources. Be sure to fill in the correct amounts in each of the relevant fields. You must enter funding in *either or both* of the fields (Direct CPA Appropriation or CPA Bonded Funds) under CPA Funding, **EXCEPT** if this project was paid for using CPA funds that had **already been transferred** to a Trust or Fund (Housing Trust or Conservation Fund).

Direct CPA Appropriation: Enter the total amount of CPA funds appropriated for this project. You *do not* have to identify which CPA account was used (such as the open space reserve account, budgeted reserve, fund balance, etc). Only enter the amount of the total appropriation, no matter which CPA account was used.

CPA Bonded Funds: If the project is being funded partially or fully by a bond against future CPA revenues, the full dollar value of the bond should be entered here. Please note that bonded projects are entered in the database only once (at the time the project is approved at the legislative body). Annual debt service payments over the loan period are not entered into the database.

CPA Bonded Term (yrs.): Enter the length of the bond term in years.

From a Trust/Fund (Housing Trust, Conservation Fund, Land Acquisition Fund or other such fund): Did the funding for this project come from CPA funds that were previously transferred to a Housing Trust Fund or a Conservation Fund? 

Important Note: when selecting the fiscal year, you will need to select the fiscal year during which the CP-3 report is due, *not* the fiscal year in which the projects were approved. For example, to submit your projects that were approved during FY2022, you will need to select FY2023 from the dropdown list (this is because the report is due on September 15th, 2022—which is in FY2023). Once a fiscal year has been selected, you will then see a list of all corresponding project names with that have been entered into the CP-3.
